**CALL TO ORDER:**

Mayor Gail Leeper called the June Special Town Council Meeting to order at 2:00pm. Present were Mayor Leeper & Council Members McLure, Clute, and O'Dell; Town Clerk-Treasurer Wight and Town Attorney Timothy M. Dick. Public Works Director Harrington were absent.

**WASTEWATER TREATMENT FACILITY UPGRADE PROJECT; USDA/RD SEWER RATES AND FUNDING**

Mayor Leeper opened the discussion on the proposed WASTEWATER TREATMENT FACILITY UPGRADE PROJECT; USDA/RD SEWER RATES AND FUNDING; acknowledging and informing the council, that USDA/RD has awarded the Town of Drummond additional Grant Funding, as project bids came in substantially higher than originally anticipated. Resulting in the need to secure additional funding and an additional required loan.

Mayor Leeper turned the time over to Steve Troendle and Lindsay Volpe to review the revised letter of conditions with the Town Council.


